The Office of Nuclear Security and Incident Response has completed its review of the revision to the Transportation Security Plan (TSP) for Classified Matter Shipments submitted December 20, 2016 (see Agencywide Documents Access and Management System (ADAMS) Accession Numbers ML16365A029, ML16365A030 and ML16365A031).

We find the revisions to the TSP to be acceptable and provide reasonable assurance that the requirements for the physical protection of classified matter will be met.

We are basing our conclusions and findings in this Safety Evaluation Report (SER) on the information provided by Centrus in their December 20, 2016, submittal and subsequent information provided on February 23, 2017 (ADAMS Accession No. ML17073A131) and on May 19, 2017 (ML17145A297).
