MEETING SUMMARY

SUBJECT: SUMMARY OF PUBLIC MEETING

On April 19, 2017, from 4:00 p.m. to 6:00 p.m., at the Town Hall, Ontario, NY, the U.S. Nuclear Regulatory Commission (NRC) conducted a public open-house to discuss its assessment of the safety performance at the R.E. Ginna Nuclear Power Plant in 2016.

A notice of the open-house was issued March 7, 2017, and posted on the NRC's external (public) Web page. The meeting notice can be found in the NRC's Agencywide Documents Access and Management System (ADAMS) with Accession No. ML17069A093. The NRC presented poster boards and fact sheets, and was available to discuss its assessment of the safety performance of the R.E. Ginna Nuclear Power Plant for the period of January 1, 2016, through December 31, 2016, as documented in our letter dated March 1, 2017 (ADAMS Accession No. ML17058A394). The NRC poster boards and fact sheets included background on the Reactor Oversight Process. Additional information relative to the NRC's Annual Assessment Process and the safety performance of the R.E. Members of the public and local officials attended the open-house and were offered the opportunity to question the NRC regarding the R.E. Ginna Nuclear Power Plant's performance, and the role of the agency in ensuring safe plant operations.
