Dear Mr. Bergman:

The U.S. Nuclear Regulatory Commission (NRC) is in the process of limiting access to NuScale Power, LLC (NuScale) proprietary information to only NRC individuals, including NRC contractors, who are responsible for reviewing NuScale design certification application. In conjunction with this activity, NRC is requesting that you provide us with the latest access controls for NRC personnel and NRC contractors that will be accessing proprietary information, including Export Control Information, such as through your Electronic Reading Room (eRR) to conduct the NuScale design certification review. Additionally, NRC needs to know the latest restrictions regarding computers used to access your eRR.

Specifically, please provide NuScale's access controls that may apply to NRC and contractor personnel for eRR access to NuScale proprietary information (for example, citizenship requirements and email account restrictions). Additionally, provide any restrictions associated with computers and other information technology equipment that will be used to access the NuScale eRR (for example, security updates or operating systems) and provide any other restrictions the NRC needs to be aware of in order to appropriately control access to proprietary documents in your eRR.

As part of our review process, we will continue to review and maintain appropriate access controls of NuScale proprietary documents. If you have any questions, please contact Gregory Cranston at (301) 415-0546 or via e-mail at Gregory.Cranston@nrc.gov.
