Purpose

The purpose of this letter is to provide supplemental changes for NR-3605-0010, *Transportation Security Plan for Classified Matter Shipments for the American Centrifuge Plant*, to the U.S. Nuclear Regulatory Commission (NRC) for review and approval.

Background

On December 20, 2016 (Reference 1), American Centrifuge Operating, LLC (ACO) submitted proposed changes to NR-3605-0010 to the NRC for prior review and approval in accordance with 10 *Code of Federal Regulations* (CFR) 95.19 and 95.39. On February 23, 2017 (Reference 2),

additional changes were made to better align with 10 CFR 95.27 and DSP-ISG-01, *Staff Review Procedure for Transportation Security Plans for Classified Matter Shipments*.

As discussed with NRC staff on May 18, 2017, additional changes have been made to clarify that the macro encapsulated solid low level mixed waste generated during Lead Cascade decommissioning efforts will be shipped off site to a treatment facility prior to being shipped for permanent burial.

Discussion

Because the intent behind these supplemental changes does not change from the initial submittal, the detailed description, justification, and ACO's significance determination as found in Enclosure 1 of Reference 1 has not changed. Enclosure 1 of this letter provides the supplemental changes to NR-3605-0010. All proposed changes to NR-3605-0010 contained within Enclosure 1 are noted in track changes with a revision bar in the right-hand margin.

Enclosure 1 contains Security-Related Information and in accordance with the guidance provided by the U.S. Department of Energy, these enclosures also contain Official Use Only information. Therefore, ACO requests these enclosures be withheld from public disclosure pursuant to 10 CFR 2.390(d)(1).


Action
