Dear Mr. Newton:

Enclosed is Amendment No. 16 to your NRC Material License No. 21-15686-01 in accordance with your request. Please note that your license format has been changed due to our new web based licensing process.

In addition, we updated Items 7 and 9 regarding the licensed materials on your license based on the information provided in the renewal application dated September 5, 2014 and the Sealed Sources and Devices Registries for the portable gauges authorized on the license.

In accordance with the licensing policy, we updated Condition No. 10 regarding the location of use, Condition No. 11 regarding the training for gauge users, Condition No. 13 regarding the sealed source leak tests, and Condition No. 15 regarding the biannual inventory. We also removed the two barriers security requirement for portable gauge in Condition No. 17 because the requirement is already specified in the regulations in 10 CFR 30.34(i). Lastly, we deleted Condition No. 19 regarding the transportation requirement, in the previous license amendment, because this requirement is in the regulations under 10 CFR Part 71.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.


You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. strongly encourage you to review this material and adapt it to your particular needs in order to develop and maintain a positive safety culture as you engage in NRC-regulated activities.
