The Pennsylvania Power and Light Co. (PP&L) is responding to the Pennsylvania Dept. of Environmental Resources (Pa DER) letter received on March 20, 1986 concerning your review of a Module #1 application for disposal of water treatment residue. At present the water treatment filtration and sludge collection systems are not operational and therefore we are unable to collect sludge samples. PP&L is reviewing alternatives for treatment of this waste stream and requests that this application be placed on hold until a treatment method is finalized. PP&L will provide equipment information as well as analysis of solids content of the sludge as soon as this information is available.

Please provide the information requested within 30 days of receipt of this letter so that final disposition on your application can be made.


The request for additional information is not an indication of a major change in the Module #1 submission. When the additional information is received by this
