TO THE HONORABLE MEMBERS OF THE HOUSE OF REPRESENTATIVES  
AND SENATORS OF THE SENATE OF THE UNITED STATES  
IN SENATE CHAMBERS, WASHINGTON, D. C.  
JANUARY 10, 1950

THE HOUSE OF REPRESENTATIVES HAS PASSED THE FOLLOWING RESOLUTION:  
RES. 100. That the sum of \$1,000,000 be appropriated for the purchase of land for the establishment of a national monument in the State of California, to be known as the "National Monument for the Preservation of the Natural Resources of the State of California," and that the Secretary of the Interior be and he is authorized to expend the same in the purchase of such land as he may deem appropriate for the purposes herein stated.

AND THE SENATE HAS PASSED THE FOLLOWING RESOLUTION:  
S. RES. 100. That the sum of \$1,000,000 be appropriated for the purchase of land for the establishment of a national monument in the State of California, to be known as the "National Monument for the Preservation of the Natural Resources of the State of California," and that the Secretary of the Interior be and he is authorized to expend the same in the purchase of such land as he may deem appropriate for the purposes herein stated.
