Dear Mr. McDonnell:

As described to you during a telephone conversation on August 14, 1987, we are informing you that five drums of hazardous wastes exceeded their 90 day storage limit allowed for hazardous waste generators. Five drums containing mixtures of formaldehyde and isopropyl alcohol became 90 days old on August 12, 1987. Delays in disposing of the wastes are due to unusually slow waste stream approval processing by our disposal company, Chemical Waste Management. The processing will be completed within the next week or two. Disposal of the drums will occur immediately thereafter. We will notify you when this occurs.
