Dear Mr. Magerr:

The U.S. Nuclear Regulatory Commission (NRC or Commission) has issued combined license (COL) No. NPF-103 for North Anna Power Station Unit 3 to Virginia Electric and Power Company, doing business as Dominion Virginia Power. Under Section 2.106 of Title 10 of the *Code of Federal Regulations* (CFR), the NRC is providing notice of the issuance of COL No. NPF-103 and, under 10 CFR 51.102(c), the NRC is providing notice of the Record of Decision (ROD).

The Commission conducted a mandatory hearing on the COL application on March 23, 2017. The Commission issued its Memorandum and Order documenting its final decision on the uncontested hearing held on March 23, 2017, which serves as the ROD in this proceeding. The NRC also prepared a document summarizing the ROD to accompany its action on the COL application; this Summary ROD incorporates by reference materials contained in the final supplemental environmental impact statement. Enclosed for your information is a copy of the Order issued by the Commission to document its decision on the hearing and Summary ROD. This hearing decision, dated May 31, 2017, authorized the staff to issue the requested license. The COL and Summary ROD were issued on June 2, 2017. The COL is effective immediately.
