Enclosed is Amendment No. 8 to your NRC Material License No. 09-32781-04MD in accordance with your February 22, 2017 (ML17055C351) request to: (1) update the diagram for your Kansas City location of use; and (2) add three Authorized Nuclear Pharmacists (ANPs) to the license. Please also note that we have deleted Condition No. 19 in accordance with current NRC policy to include the reference to Title 10 of the *Code of Federal Regulations, Part 71*, "Packaging and Transportation of Radioactive Material," in the preamble, on page 1 of the license. We have also renumbered some conditions, and updated other conditions in accordance with current NRC licensing policy. Finally, we have added NRC's Agencywide Documents Access and Management System (ADAMS) document accession numbers to the documents referenced in Condition No. 20 to the amended license.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.
