On April 27, 2017, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Sequoyah Nuclear Plant, Units 1 and 2. The results of this inspection are documented in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
