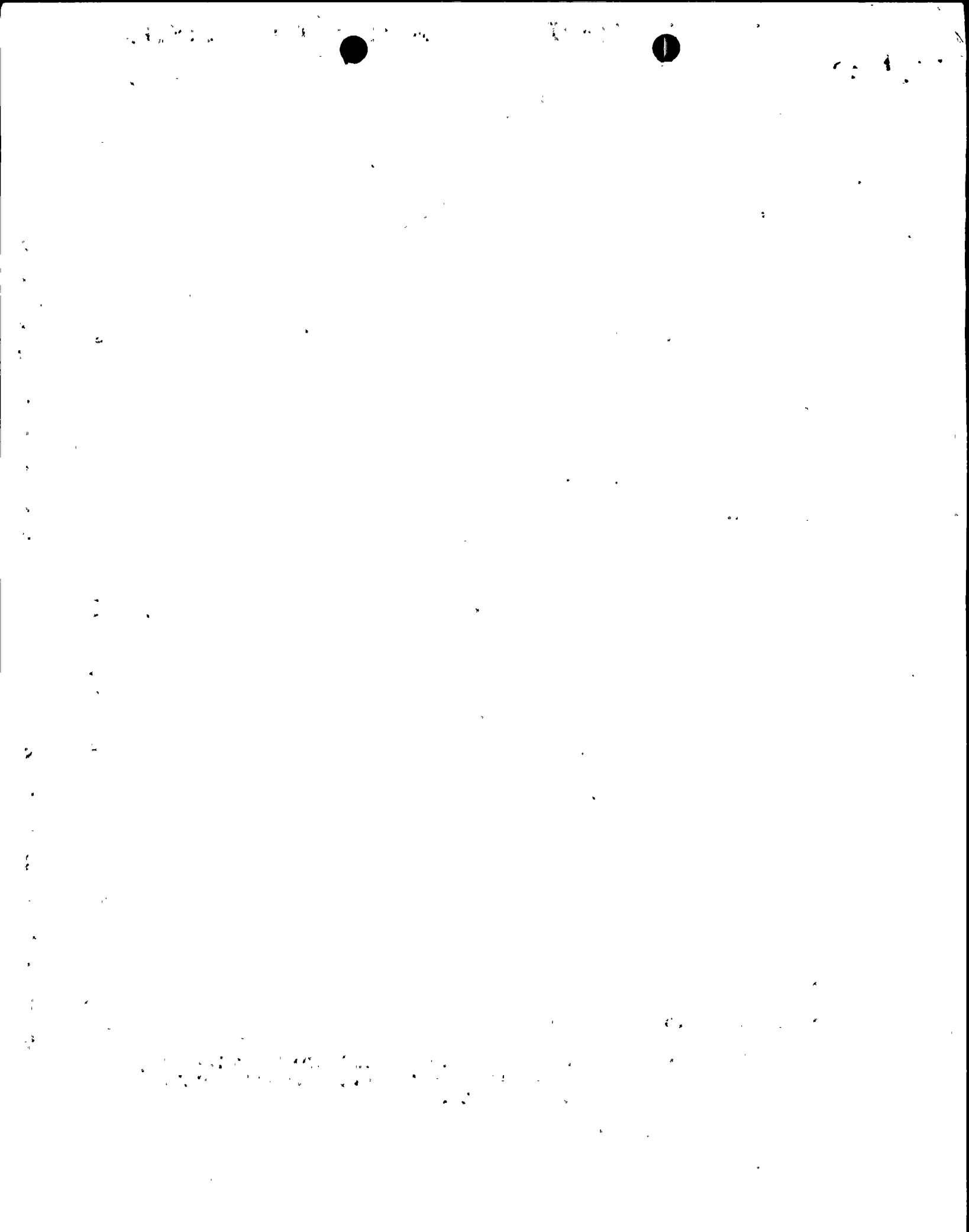

Dear Dr. Butler:

The purpose of this letter is to provide PP&L's response to Generic Letter 89-08, wherein NRC requested information on whether or not a long term erosion/corrosion monitoring program that provides assurances that the NUMARC program or another equally effective program is implemented and the structural integrity of all high energy (two phase and single phase) carbon steel systems has been implemented or will be implemented.

Presently, PP&L's erosion/corrosion program meets or exceeds the NUMARC program and is implemented through four formalized procedures.

For the long term we are planning to enhance our existing procedures based on data gathered during refueling and inspection outages. Specifically we are committed to the following:

- Incorporate the erosion/corrosion program into an existing Nuclear Department procedure.
- Develop and incorporate into the erosion/corrosion program, a formal trending program
- Incorporate the erosion/corrosion program into the Inservice Inspection Program database.
