Subject: Enforcement Conference (Meeting Report No. 50-388/89-25)

This refers to the Enforcement Conference held on October 3, 1989, at the NRC Region I Office, King of Prussia, Pennsylvania. The purpose of the conference was to discuss the circumstances, evaluations, corrective actions, and apparent violations associated with the unplanned occupational exposure of a contractor employee which occurred at Susquehanna Unit 2 on August 31, 1989. Our findings relative to this unplanned exposure were provided to you in NRC Inspection Report No. 50-388/89-25. The report was sent to you on September 14, 1989. The enclosed meeting report summarizes the discussions held at the Enforcement Conference.

The conference helped us to better understand your corrective actions taken following the identification of the unplanned exposure.

No reply to this letter is required. You will be notified of our evaluation of appropriate enforcement action at a later date.
