In PP&L's response to NRC Bulletin 88-10 (PLA-3152 dated March 31, 1989), we indicated that five breakers would be replaced or tested prior to startup following the Susquehanna SES Unit 2 refueling outage which is currently in progress. Three of these breakers were installed in Unit 2 and have been replaced. The remaining two breakers are installed in a battery charger for the "E" Diesel Generator. Due to procurement delays, replacements for these breakers may not be available until January, 1990. PP&L is attempting to expedite delivery and will replace the breakers as soon as practicable.
