

## 1990 NRC OBSERVED EXERCISE CYCLE

Another conflict has arisen with our scheduled NRC exercise. The NRC will be conducting initial operator exams the week of April 9. It would be possible to work the April 10 emergency exercise around this; however, it seems more prudent to move the exercise back a week and avoid the conflict completely.

I would like your approval to change the drill date to April 18 and to schedule the practice drills for February 13 and March 13.
