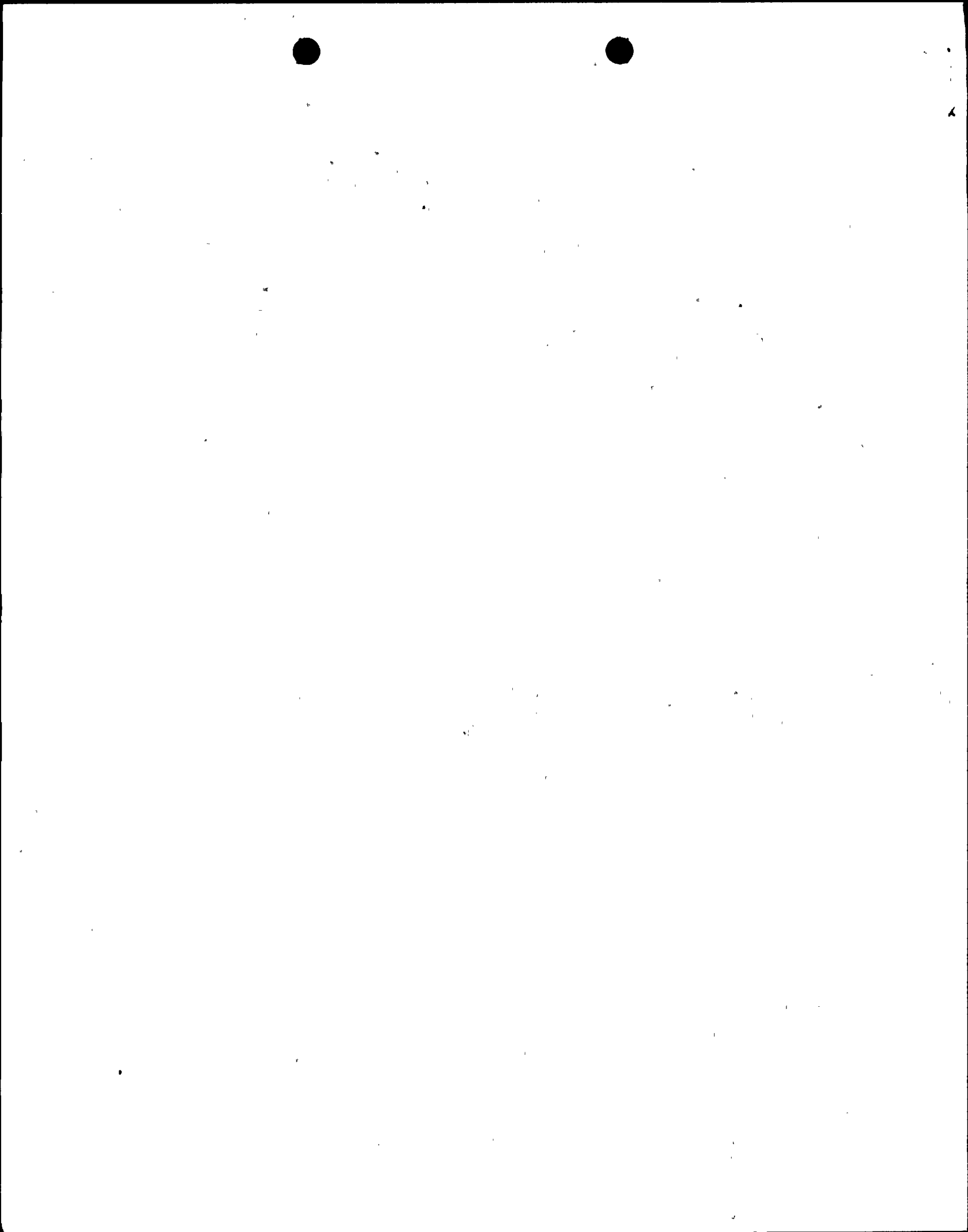

The pending reload submittal for Unit 2 Cycle 5 (scheduled startup date: May 10, 1991) is based on these methods, and all future PP&L reload submittals are planned to be based upon them as well.

Mr. Kulin Desai (NRR-SRXB) has requested that PP&L provide a presentation to the NRC staff regarding our qualifications to perform reload licensing analyses and an overview of the topical reports. 

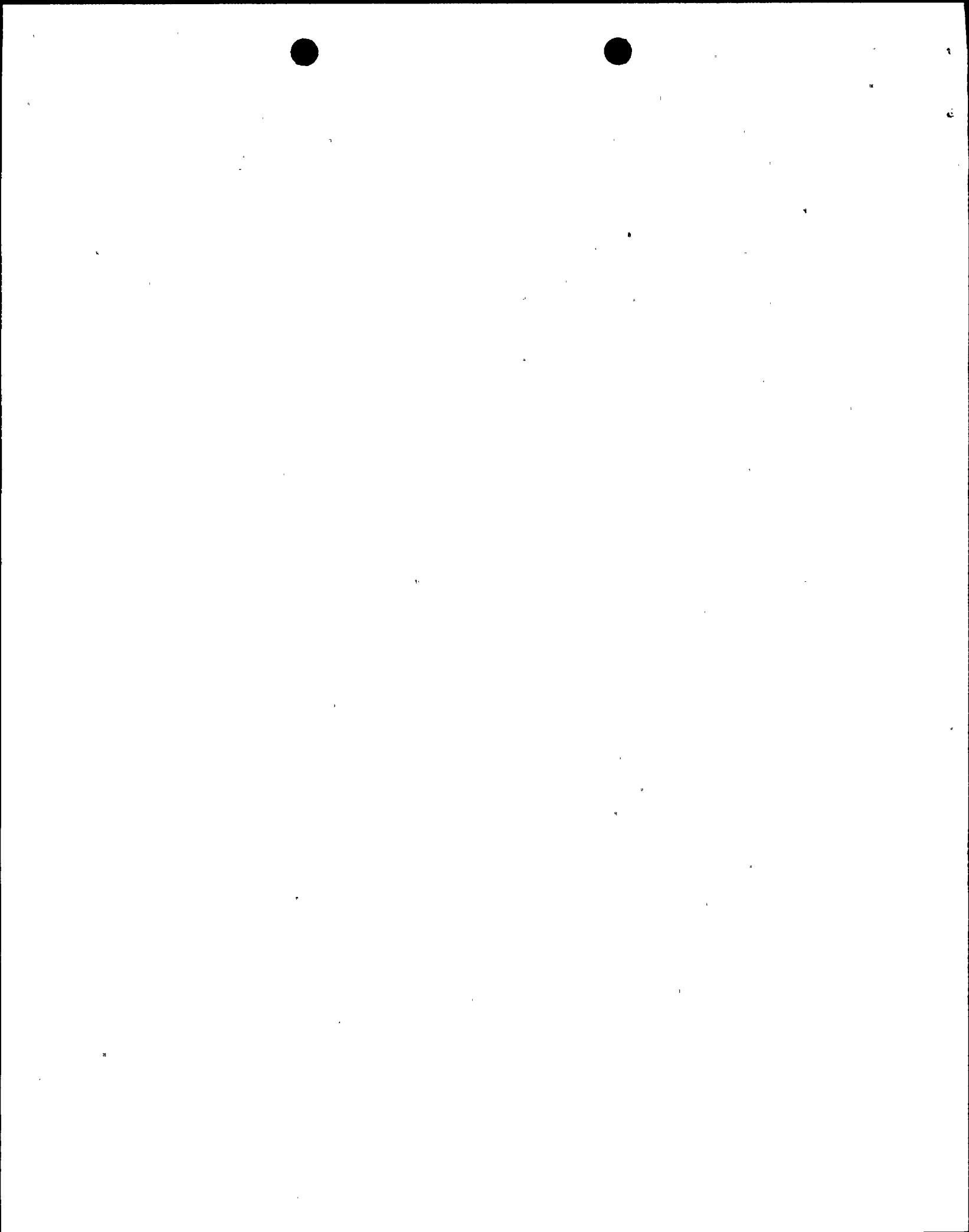
