Dear Mr. Gallo:

PP&L is providing a revised EOP response as requested by your staff during a September 28, 1990, telephone call where PP&L explained our priority system to resolve open EOP items identified in your inspection report 387/90-80 and 388/90-80. This teleconference resulted in PP&L reviewing and revising the priorities of a number of open items identified in the EOP inspection. Those items are annotated with an asterisk (*) on the attachment to this letter.

PP&L has prioritized open EOP issues into three categories. Priority 1 items warrant early consideration and are being actively pursued to resolution. The priority 1 items identified on the attachment will be completed, to include any training, by June 30, 1991. Priority 2 items require EOP revisions to increase efficiency of execution; however, the EOPs as currently written are adequate. Priority 2 items will also be completed by June 30, 1991. Priority 3 items are enhancements only and do not affect execution of the EOP's. Resolution of priority 3 items identified on the attachment will be addressed either by June 30, 1991, or in conjunction with our EOP upgrade to Revision 4 of the BWROG EPG's. The upgrade is currently scheduled to be completed by January 31, 1993. Training associated with this upgrade will also be completed by January 31, 1993.
