Attached is Licensee Event Report 91-016-01, which supplements Licensee Event Report 91-016-00, issued December 20, 1991. A condition was determined reportable per 10CFR50.73(a)(2)(ii)(B) in that a "hot short" resulting from a postulated Appendix R Control Room fire could place the plant in a condition that would be outside of its analyzed design basis. PP&L is conducting detailed analyses to justify a request for deviation from the Appendix R requirements for this postulated condition. This has previously been stated in a letter to the NRC, PLA-3918, dated February 24, 1993.
