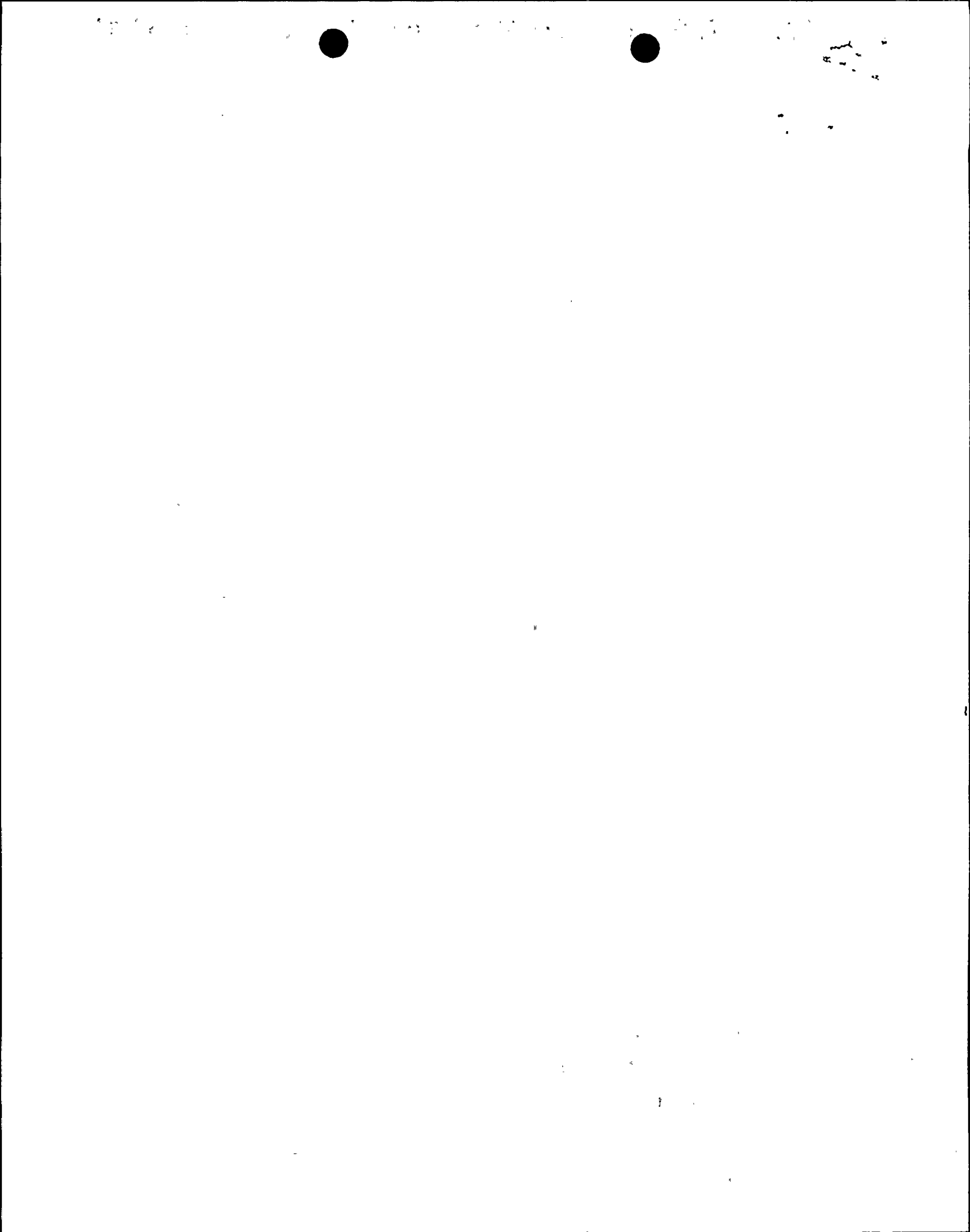

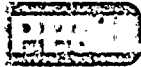

Dear Duane:

In response to your letter of March 25, 1993 containing the U.S. Army Corps of Engineers (Corps) March 17, 1993 letter, the Pennsylvania Power and Light Co. (PP&L) concurs with Penelec/GPU that the Corps' response to the issue of release of liability from contractor claims is complete. However, we feel that the issue of liability for the low flow gate replacement still needs to be resolved.

We recommend that the Corps' investigative committee take actions necessary in determining responsibility or responsibilities for failure of the original low flow gates. Also, we would like to review the Corps' report concluding that the low flow gate liability was not clearly defined. Both Penelec/GPU (letter to SRBC dated April 29, 1993) and PP&L concur that this action is necessary in meeting Article 11, Release of Claims Section of the SRBC/Corps Cowanesque Lake Modification project.
