An announced safety inspection of the radwaste/transportation program at your facility was conducted by Mr. J. Noggle on June 7-10, 1993. The inspection findings were discussed with your staff on June 10, 1993.

Areas reviewed during the inspection were important to health and safety and are discussed in the enclosed inspection report. These areas included review of: audits and assessments, program and personnel changes, solid radwaste processing, and transportation activities.

As a result of the inspection it was concluded that your performance in the radwaste/transportation area was excellent. Within the scope of this inspection, no violations were identified. One weakness was identified relative to the lack of radioactive shipping regulations training provided to your radwaste shipping personnel.
