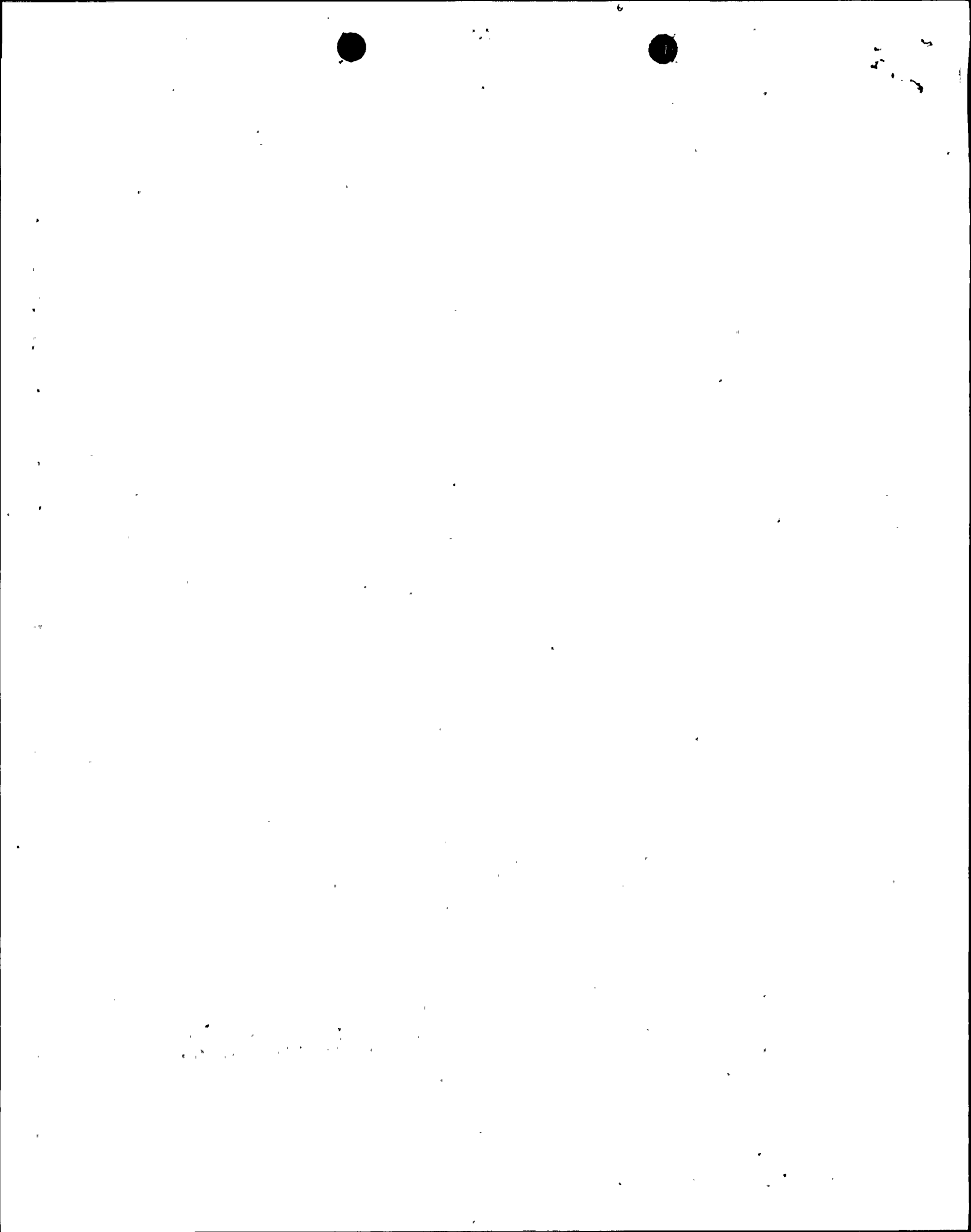

Dear Mr. Boyle:

We received your letter dated August 17, 1993 enclosing additional information from the Pennsylvania Power & Light Company presentation to the staff on July 8, 1993 and indicating that our presentation to the staff on the 10 CFR Part 21 report has been tentatively scheduled for October 1, 1993.

As you requested in a telephone conversation with Mr. Lochbaum on August 12, 1993, we are providing the following proposed agenda for this meeting:

- INTRODUCTION
- SUSQUEHANNA STEAM ELECTRIC STATION (SSES) DESIGN OVERVIEW
- SSES DESIGN BASES ACCIDENT (DBA) LOSS OF COOLANT ACCIDENT (LOCA)
- DEFICIENCIES IN PP&L'S POSITION ON LOSS OF FUEL POOL COOLING EVENT
- PP&L'S PROGRAMMATIC FAILURES ON NUCLEAR SAFETY ISSUES
- ISSUES REQUIRING RESOLUTION TO ASSURE SAFE OPERATION AT SSES

We understand that this meeting will be between the staff and ourselves, with all other attendees free to observe the meeting but cannot participate. These were the ground rules imposed for the March 18, 1993 meeting between PP&L and the NRC which we attended but were prohibited from commenting during the meeting.

We appreciate this opportunity to meet with the staff and discuss the safety concerns we identified in the 10 CFR Part 21 report.
