This letter supersedes PLA-4073, dated January 7, 1994. The purpose of this letter is to document correction of a typographical error in the referenced proposed amendment at the request of Mr. M. Razzaque of NRR/SRXB. Please be advised that on page 35 of the reference, the maximum fuel cladding temperature limit specified should be 2200°F, not 220°F. This is consistent with the criteria in NUREG-0460.


