This letter provides PP&L's response to 'Required Information' Part 1 of Generic Letter 92-01 Revision 1, Supplement 1, "Reactor Vessel Structural Integrity" as follows:

'Required Information' Part (1): a description of those actions taken or planned to locate all data relevant to the determination of RPV integrity, or an explanation of why the existing data base is considered complete as previously stated:

PP&L reply to 'Required Information' Part (1):

PP&L believes that the above referenced submittals to the NRC regarding the composition of materials and mechanical properties required for compliance with 10CFR50 Appendices G and H were complete at the time of the submittals. We have not uncovered any new information since the above submittals were made to NRC which alters the results or conclusions of these submittals or reduces the safety margins now being used in the operation of Susquehanna Units 1 and 2.



We have reviewed the proposed generic response, "BWRVIP Action Plan for RPV Integrity Data", to NRC Generic Letter 92-01, Revision 1, Supplement 1, that will be referenced by all the domestic utilities comprising the BWR Vessel & Internals Project (BWRVIP). We will utilize the data gathered as a result of this action plan to respond to Generic Letter 92-01, Revision 1, Supplement 1. When the BWRVIP action plan report and data become available we will evaluate them and make any appropriate changes to the structural evaluation of the Susquehanna RPVs, if warranted by new data found. Our response to 'Required Information' Parts (2), (3), and (4) of the Generic Letter 92-01, Revision 1, Supplement 1 will document this evaluation.

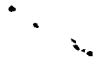
