PROGRAM SCOPE								
This was a routine inspection of a 200 bed hospital that was authorized to use byproduct materials in 10 CFR Sections 35.100, 35.200, 35.300, and 35.400. The nuclear medicine area was staffed with two full time technologists who administered 5 to 8 diagnostic administrations daily in addition to five administrations of I-131 since the last inspection. The nuclear medicine staff received unit doses from an area pharmacy with no generators. The radiation oncology department (three authorized users) was authorized to do manual brachytherapy procedures. The licensee had performed 8-10 permanent prostate seed implant procedures since the previous inspection.								
PERFORMANCE OBSERVATIONS								
Interviews of available staff revealed an adequate level of understanding of emergency and material handling procedures and techniques. Within each functional area, the licensee successfully demonstrated routine equipment QA/QC checks, package receipt, area surveys, and waste handling and disposal procedures. A contract physicist performed quarterly audits to help oversee the nuclear medicine program. The inspector observed one rest stress test with no concerns. The inspector confirmed that these activities were successfully and routinely completed by reviewing selected records. The inspector also reviewed selected records for I-131 and manual brachytherapy administrations requiring a written directive since the previous inspection. The licensee's records and procedures demonstrated that each administration was in accordance with the written directive. Records for brachytherapy treatments were maintained off site by the contract physics group. Licensed material was adequately secured and not readily accessible to members of the general public. The licensee possessed radiation survey meters that were calibrated and operational. Personal whole body and extremity dosimetry badges were observed being worn by the staff during the inspection, and records did not indicate doses in excess of 10 CFR Part 20 limits. No violations of NRC requirements were identified as a result of this inspection.
