
Generic Letter 96-06 titled "Assurance of Equipment Operability and Containment Integrity During Design-Basis Accident Conditions" requires a 30 day response and requests a 120 day response. This letter provides PP&L's 30 day response.

The 30 day response requires PP&L to indicate if the actions requested by the 120 day response will be completed, if the requested information (summary report stating actions taken) will be submitted to the NRC, and if the requested information will be submitted within 120 days requested by the Generic Letter.

PP&L will comply with the three requests as specified in the Required Response section of Generic Letter 96-06.
