Provided that no technical issues arise during our evaluation which would preclude implementation of the subject standard, PP&L will submit proposed changes to the Unit 1 and Unit 2 Technical Specifications by the end of 1997.

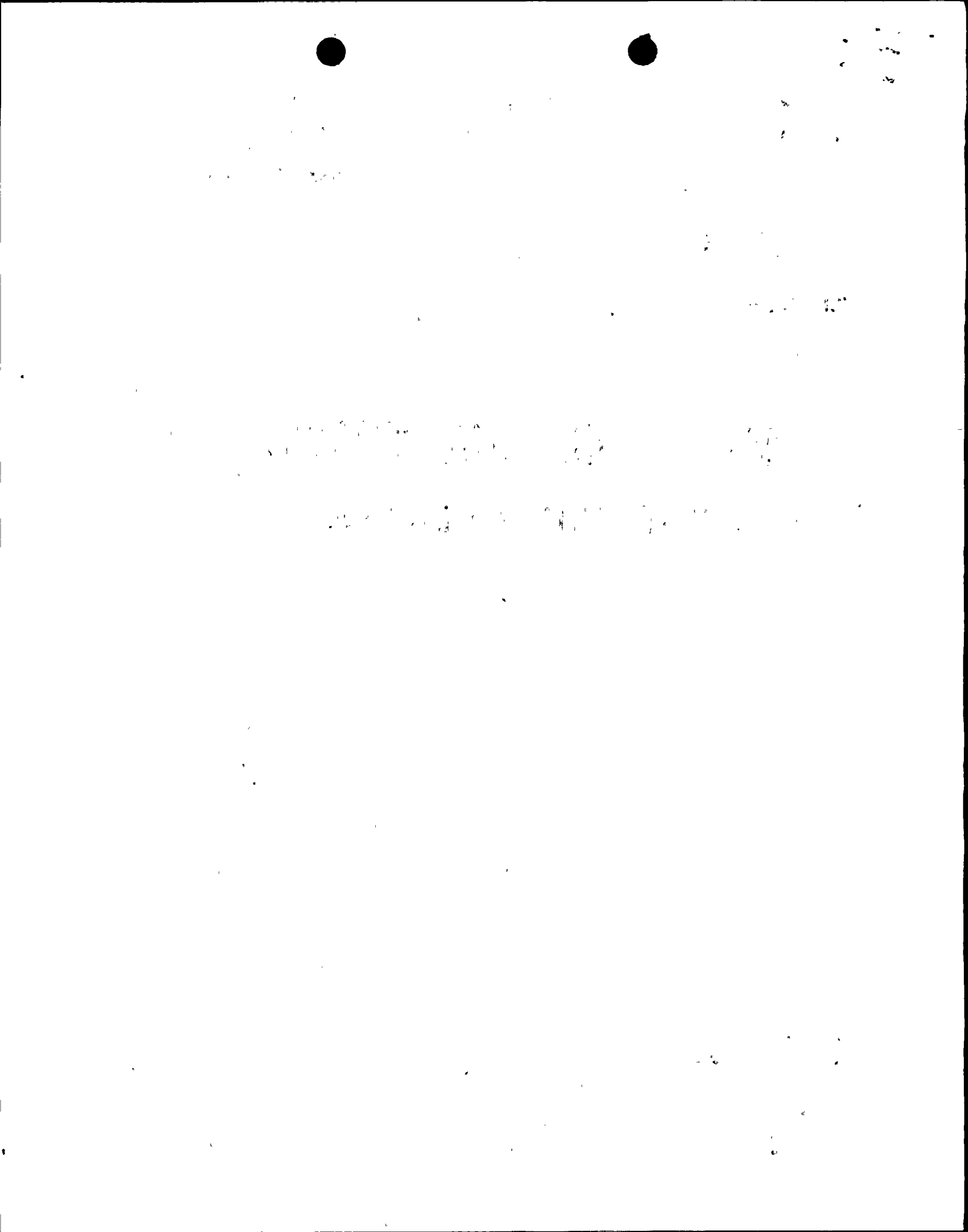

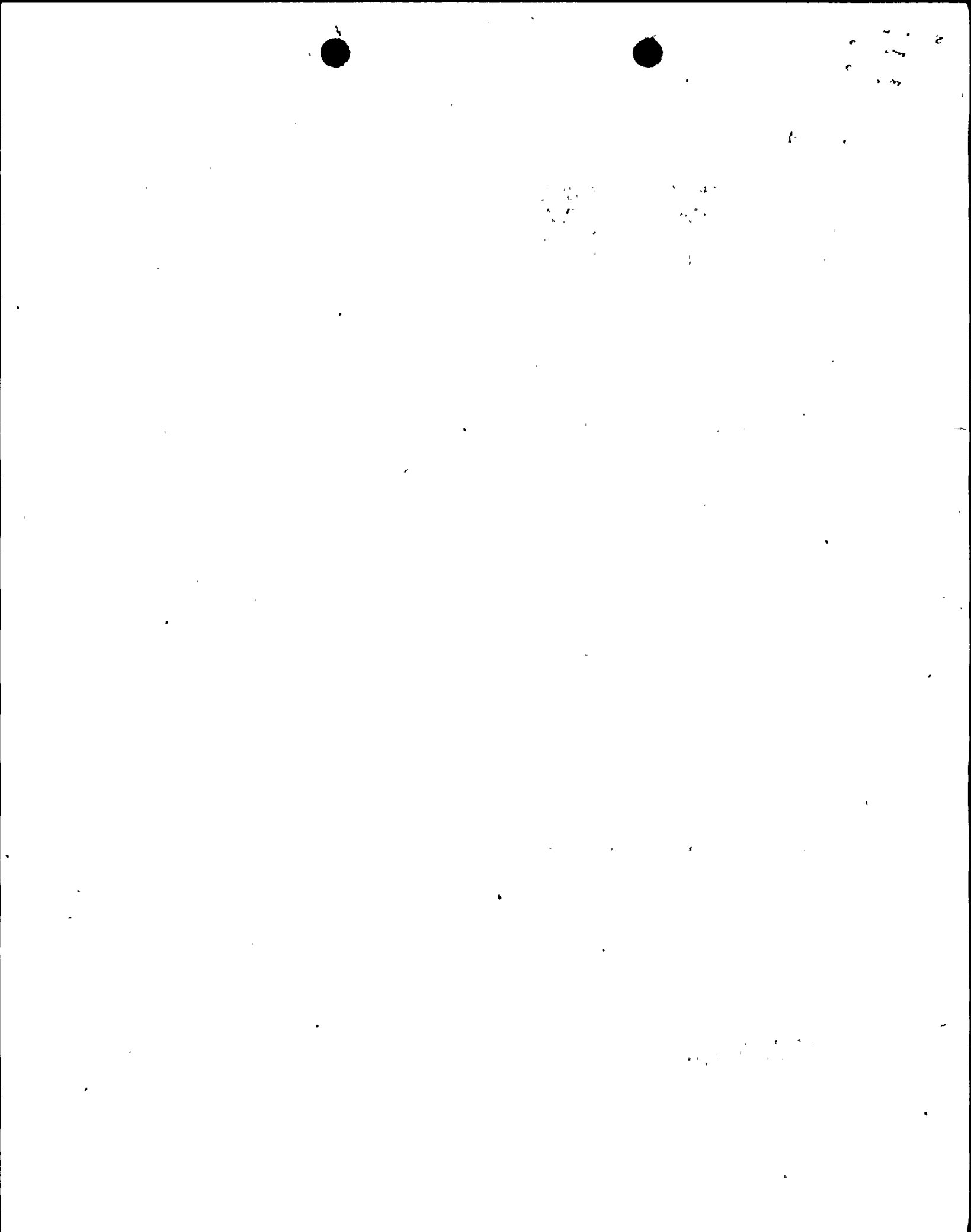
