This letter proposes changes to the Susquehanna Steam Electric Station Units 1 and 2 Technical Specifications 6.2.2g and 6.3.1 to permit an individual who does not hold a current Senior Reactor Operator (SRO) license to hold the position of Manager-Nuclear Operations. An individual serving in the capacity of the Operations Supervisor-Nuclear, will hold a current SRO license and report directly the Manager-Nuclear Operations and be responsible for directing the licensed activities of licensed operators. It should be noted that Improved Technical Specification (5.2.2.f) allows the Unit Staffing proposed by this change.

Enclosure A to this letter is the "Safety Assessment" supporting these changes. Enclosure B to this letter is the "No Significant Hazards Considerations" performed in accordance with the criteria of 10 CFR 50.92. The proposed changes have been reviewed by the Susquehanna SES Plant Operations Committee and the Susquehanna Review Committee.

Enclosure C to this letter is the current pages of the Susquehanna SES Units 1 and 2 Technical Specifications marked to show the proposed changes.

PP&L plans to implement the proposed changes as soon as possible after approval.
