SUBJECT: NOTICE OF CONSIDERATION OF APPROVAL OF TRANSFER OF CONTROL

(CHANGE OF CONTROL) FROM AUC LLC TO URANIUM ENERGY CORP LICENSE SUA-1602, RENO CREEK ISR PROJECT, CAMPBELL COUNTY, WYOMING, OPPORTUNITY TO PROVIDE COMMENTS AND TO REQUEST A

HEARING (CAC NO. L00840)

Dear Dr. Longie:

The U.S. Nuclear Regulatory Commission (NRC) received and is considering approval of an application submitted by AUC LLC (AUC) and Uranium Energy Corp (UEC) dated May 8, 2017. The application seeks NRC approval of the indirect transfer (change) of control of NRC Materials License SUA-1602 for the Reno Creek In-Situ Recovery (ISR)¹ Project ("Reno Creek") from AUC to UEC. The NRC is notifying you of this action as you may have an interest.

Under NRC Materials License SUA-1602, AUC is the current licensee for Reno Creek located in Campbell County, Wyoming. The membership of AUC is held solely by AUC Holdings, Inc. (AUCHI), a corporation organized under the laws of Nevada. AUCHI is wholly owned by Reno Creek Resources, Inc., a British Columbia, Canada, corporation, which is wholly owned by Reno Creek Holdings, Inc., also a British Columbia corporation. Although Reno Creek has a license, no active operations or construction has commenced.

On May 8, 2017, Uranium Energy Corp (UEC), a corporation organized under the laws of Nevada, announced that it would acquire all the outstanding shares of Reno Creek Holdings, Inc. and, upon completion of the acquisition, Reno Creek Holdings, Inc. would become a wholly-owned subsidiary of UEC. Reno Creek Holdings, Inc. will retain 100 percent ownership of Reno Creek Resources, Inc., which will retain 100 percent ownership of AUC Holdings, Inc. which will remain the sole owner of AUC LLC.

The licensee is not seeking an amendment to the license. The applicants have stated, "AUC will continue to be listed as the licensee under its current name "AUC LLC." If AUC should choose to change its name post-closing, it will submit a request to NRC for an administrative

license amendment to reflect the change of name." Additionally, the licensee has stated, "UEC does not contemplate making any changes to AUC's staffing structure" at Reno Creek.
