**Radium Program Technical Support**

On May 31, 2017, Blanket Purchase Agreement (BPA) number NRC-HQ-50-17-A-0001 was awarded to Oak Ridge Associated Universities, Inc. in Oak Ridge, Tennessee. The objective of this BPA is to obtain expert technical assistance services to assist and support the NRC in determining the current radiological status of sites where byproduct material (specifically discrete sources of radium-226) was historically used, or suspected to be used historically, for commercial, medical, research, or military activities. The period of performance of this BPA is from May 31, 2017, to May 30, 2018, with four 1-year options. The potential value over the life of the BPA is \$5,307,544.

**List of Approved Spent Fuel Storage Casks: NAC International MAGNASTOR® Cask System; Certificate of Compliance No. 1031, Amendment No. 7, Direct Final Rule; Part 72 of Title 10 of the Code of Federal Regulations (Regulation Identifier Number 3150-AJ89; NRC-2017-0008)**

On June 6, 2017, the NRC published a direct final rule in the *Federal Register* ([82 FR 25931](#)) amending its spent fuel storage regulations by revising the NAC International MAGNASTOR® Cask System listing within the “List of approved spent fuel storage casks” to include Amendment No. 7 to Certificate of Compliance No. 1031. Amendment No. 7 provides a new Passive MAGNASTOR® Transfer Cask and associated Technical Specification (TS) changes in Appendices A and B, and updates Section 4.3.1(i) in Appendix A of the TSs to include revised seismic requirements. Clarifying (non-technical) changes were also made to Appendices A and B. The companion proposed rule was also published in the *Federal Register* on June 6, 2017 ([82 FR 25973](#)). Unless significant adverse comments are received, the direct final rule will become effective on August 21, 2017.

**Global Infrastructure and Development Acquisition (GLINDA) Blanket Purchase Agreement (BPA)**

On June 9, 2017, NRC completed the award of six (6) BPAs for GLINDA. The objective of these BPAs is to provide the NRC with a wide range of IT infrastructure and application maintenance and operations services. The initial period of performance for all six (6) BPAs extends through September 29, 2019, with three 1-year options. BPAs were awarded to:

- Actionet, Inc. in Vienna, Virginia (NRC-HQ-10-17-A-0003)
- CGI Federal, Inc. in Fairfax, Virginia (NRC-HQ-10-17-A-0004)
- Vistronix, LLC in Reston, Virginia (NRC-HQ-10-17-A-0005)
- GS2F, Inc. in Reston, Virginia (NRC-HQ-10-17-A-0006)
- Leidos Innovations Corporation in Herndon, Virginia (NRC-HQ-10-17-A-0007)
- Synaptex Corporation in Reston, Virginia (NRC-HQ-10-17-A-0008)

The total potential value over the life of all of the GLINDA BPAs is \$679,000,000.

**Radiation Protection Strategic Research Needs Workshop**

From June 5-6, RES presented an overview of NRC's radiation protection research and input for the first *Radiation Protection Strategic Research Needs Workshop* in Oak Ridge, Tennessee. This workshop, hosted jointly by Oak Ridge Associated Universities (ORAU), Oak Ridge National Laboratory, and the Health Physics Society, hosted 20 universities, 21 Federal agencies and 3 National laboratories to discuss and prioritize short- and long-term radiation research topics that would help the nation. ORAU will collate and develop a high-level radiation protection research needs document in the upcoming months on the key outcomes of the meeting, which could be shared with Congress to support future funding for research in this area, including completing the Million Worker Study for low level effects.
