In Reference 1, the U.S. Nuclear Regulatory Commission (NRC) transmitted a revised 10 Code of Federal Regulations (CFR) Part 71 Quality Assurance Program Approval for Radioactive Material Packages (i.e., No. 0240, Revision 10) for the following Entergy Nuclear Operations, Inc. (Entergy) nuclear stations:

- Indian Point Nuclear Generating Station Units 1, 2 and 3
- Pilgrim Nuclear Power Station
- James A. FitzPatrick Nuclear Power Plant

In Reference 2, Exelon Generation Company, LLC (EGC) requested that 10 CFR Part 71 Quality Assurance Program Approval No. 0008 be revised to incorporate the James A. Fitzpatrick Nuclear Power Plant, following the transfer of the renewed facility operating license and Independent Spent Fuel Storage Installation general license from Entergy to EGC.

Entergy requests that 10 CFR Part 71 Quality Assurance Program Approval No. 0240 be revised to remove the James A. Fitzpatrick Nuclear Power Plant.

This letter contains no new regulatory commitments.
