Hello Ty,

OGC-HLW has completed its review of the MIT License Renewal Package. There are a number of questions, comments, and revisions in the SER and transmittal letter, but there are no major problems with the Package documents. I have a few questions that I think we will need to discuss - and we may need to bring an author of a section into the discussion.

I have made the MAJORITY of comments on the NON-PUBLIC SER. I have reviewed the PUBLIC SER and they are nearly identical. I have made comments on the PUBLIC SER - mainly stating that changes in the Non-Public version should be added to the Public version. I have a few additional questions on the Public Version.

The main unresolved issues seem to involve citations to the wrong documents (and missing ADAMS Numbers), misstatements about the documents cited, and inconsistent/confusing citation formats.

Please take a look at OGC's comments and revisions - and accept all that are appropriate. And please respond to any of OGC's questions that you can answer. Then I think it may be useful to work on the document together to resolve any questions and / or formatting issues you have. I have found it useful to work on a document in Skype for Business - with both persons able to review the document and make changes at the same time (like SharePoint - but better since I can't get into your SharePoint and you can't get into OGC's). Let me know if you have used Skype for Business.

Let me know if you have any questions. Please let me know when you have reviewed the Package.
