Dear Chairman Svinicki:

I am appointing Ms. Angela E. Leek as the State Liaison Officer to the NRC from the State of Iowa. Ms. Leek is the Chief of Iowa's Bureau of Radiological Health and is in a position within State government that affords her access to my office and other State agencies in order to convey important and time-sensitive information provided by the NRC. Ms. Leek is also in a position within Iowa State government to be able to keep your agency informed of important regulatory, legislative and public interest issues as they occur within the state.

As the Governor-appointed State Liaison Officer, Ms. Leek will also function as my State employee representative, as provided for in Part 73.59(e) of your regulations, for receipt of Safeguards Information (SGI) and Safeguards Information-Modified Handling (SGI-M) that may be transmitted by the NRC. Ms. Leek has been informed of the protection requirements for SGI and SGI-M and will establish the controls necessary to maintain compliance with Parts 73.21 through 73.23 of your regulations. Her agency possesses the necessary physical protection resources for properly storing SGI and SGI-M.
