#### Status of Recommendations

Recommendation 1:

Finalize and implement a formal MD 6.5 implementation plan that includes elements such as management authority, office coordination, and milestones.

Agency Response Dated  
May 25, 2017:

Regarding the first recommendation, "Finalize and implement a formal MD 6.5 implementation plan that includes elements such as management authority, office coordination, and milestones," the staff has issued and is executing a formal implementation plan for Management Directive (MD) 6.5, "NRC participation in the Development and Use of Consensus Codes and Standards." The staff was developing this implementation plan following the issuance of the MD in October 2016 to implement the new MD and enhance coordination of the staff's Codes and Standards program. Therefore, the staff's actions to implement the MD began during the performance of the audit and address the first recommendation.

OIG reviewed the MD 6.5 implementation plan, as well as an accompanying memo notifying cognizant agency managers of the revised MD 6.5. #### Status of Recommendations

Agency Response Dated  
May 25, 2017:

In response to the second recommendation, "Finalize and implement controls in the MD 6.5 implementation plan to strengthen ASME code committee representatives' adherence to ethics policies, such as but not limited to, financial disclosure reporting," the staff plans to assess the internal controls that are in place to ensure adherence to ethics policies and will determine whether additional controls are needed for staff participation in activities involving the development of codes and standards.
