Thank you for your email below regarding the Army's application to amend SUC-1593. Our acknowledgement letter to the Army regarding its amendment request should be publicly available. Dear Mr. Dapas:

In the cover letter of June 1, 2017 regarding a request to amend the environmental radiation monitoring plan for depleted uranium possession license SUC 1593, the U.S. Army requests that it be granted exemption from requesting an amendment when making corrective changes to the license and its annexes (see ML17158B356).

I ask that this exemption NOT be granted. The extent of what may be changed is nebulous and must be specifically detailed, which it is not. This is too important an issue for public health and safety; a blank check for modifications to the license and its conditions should not be given in any circumstance.

If necessary, if this exemption is granted, please consider this concern of mine to be a 2.206 petition requiring further review.
