Reference (a) transmitted Commonwealth Edison's request to change the Technical Specifications for Quad-Cities Units 1 and 2 regarding the removal of reactor water cleanup system return isolation valve M0-1201-80 from Table 3.7-1, "Primary Containment Isolation," and exclude the valve from the surveillance described in Section 4.7.D.

Reference (b) stated that the requested Technical Specification change should be considered a Class III and Class I amendment and not a Class II and Class I amendment as stated in Reference (a). This change in classification represents a fee difference of \$2,800.00.
