Dresden Station Units 1, 2 and 3 Subject: Proposed Change to Facility Operating License Nos. DPR-2, DPR-19 and DPR-25 NRC Docket Nos. 50-10, 50-237 and 50-249

Dear Mr. Denton:

Pursuant to References (a) and (b) and 10 CFR 50.59, Commonwealth Edison Company hereby requests a change to Operating License Nos. DPR-2, DPR-19 and DPR-25, Appendix A, Technical Specifications. The purpose of this amendment is to revise the Dresden Station Technical Specifications to conform to the requirements of 10 CFR 50, Appendix I, "Numerical Guides for Design Objectives and Limiting Conditions for Operation to Meet the Criterion 'As Low As Practicable' for Radioactive Material in Light-Water-Cooled Suclear Power Reactor Effluents." The proposed changes to the Dresden Station Technical Specifications are enclosed in Attachment 1A for Unit 1 and Attachment 13 for Units 2 & 3. Attachment 2 contains an Offsite Dose Calculation Manual (ODCM) for Dresden Station as required by Reference (b). In addition, a discussion of Commonwealth Edison's principal differences from NRC Guidelines for the development of the ODCM is contained in Attachment 3.

The proposed Dresden Station Technical Specifications of Attachments 1A and 1B follow as closely as practicable the model technical specifications of Reference (a). However, since -nem 1004 40/40 7902260431 w/ CHECK 7902260431 FOR \$8,400.00 the model technical specifications were not prepared explicitly ADC for Dresden Station, some changes were necessary to adapt them to the Dresden design and nomenclature.

The proposed technical specification changes of Attachments LA and LB and the ODCM of Attachment 2 have been reviewed and approved by the Commonwealth Edison On-Site and Off-Site Review with the conclusion that there are no unreviewed safety questions.

In conjunction with Reference (a) and pursuant to 10 CFR 170, Commonwealth Edison has determined that this proposed amendment is a Class III Amendment for Unit 1 and a combined Class III and Class I Amendment for Units 2 & 3. As such, Commonwealth Edison has enclosed a fee remittance in the amount of \$8,400.00 for this proposed amendmant.
