Dear Mr. Reed:

As recently discussed with you in connection with the NRC Systematic Evaluation Program (SEP), the Senior Seismic Review Team (SSRT) headed by Dr. Nathan M. Newmark, is nearing completion of our seismic review of the Dresden Unit No. 2 facility. Your staff's cooperation has contributed significantly in enabling this difficult project to reach this stage of completion and supports my view of how SEP can best utilize our joint efforts to resolve important issues.

In order for the SSRT to complete its report, additional existing information and points of clarification are needed. These items are identified in Enclosure 1. We have discussed this request with your representatives and they have agreed to provide the necessary information.

Additionally, the SSRT has identified certain items that require further study beyond the expected scope of our review to assure seismic design adequacy. These items are identified in Enclosure 2.

In some cases, the requirement for further evaluation of the items listed in Enclosure 2 results from a lack of sufficient equipment qualification documentation to allow a judgment concerning the seismic design adequacy. While most of the equipment and distribution systems appear adequate, documentation to support this belief has not been developed. Additionally, for some equipment it appears prudent to increase seismic resistance. Therefore, you are requested to supply information for our review to enable us to make a determination regarding the seismic design adequacy of the items listed in Enclosure 2. As you are aware, the SEP was structured to enable a balanced decision at the end of the program with respect to potential backfitting considerations.
