References (a) and (b) provided our schedules for performing the IPCLRT for the first ten-year intervals for Dresden Units 2 and 3.

For Dresden Unit 2, the scheduled tests (see Ref. (b)) have all been completed, satisfying the requirements of Appendix J to 10 CFR 50 and the Technical Specifications for the first ten-year inter-The second ten-year interval will commence on February 26, 1981, val. to coincide with the Inservice Inspection (ISI) Program second tenyear interval. Our current schedule calls for the first IPCLRT for the second interval to be performed early in 1983 with the other tests during the interval scheduled in accordance with Appendix J and the Technical Specifications. The third test is expected to be performed when the unit is shutdown for the end of the second interval ISI examinations.

For Dresden Unit 3, the third IPCLRT test in the first ten-year interval is currently scheduled for 1980 (see Ref. (a)). Based on our current refueling outage schedules, this would require the second and third tests to be performed during consecutive outages.
