Dear Mr. Ippolito:

Reference (a) transmitted Amendments Nos. 44 and 39 to Facility Operating Licenses Nos. DPR-19 and DPR-25 for Dresden Units 2 and 3 and Amendments Nos. 53 and 50 to Facility Operating Licenses Nos. DPR-29 and DPR-30 for Quad-Cities Units 1 and 2, in response to our applications dated May 16, 1977 and November 3, 1978.

Our review of these amendments indicate that an error was made in the incorporation of the requested changes into the Technical Specifications. Subsequent to our original submittals (May 16, 1977 and November 3, 1978) and prior to the issuance of the subject amendments (August 13, 1979), additional changes to some of the same Technical Specification pages were approved under Amendments 39 and 37 for DPR-19 and DPR-25 and Amendments 48 and 47 for DPR-29 and DPR-30. The error resulted when changes approved under Amendments 44, 39 (DPR-19, 25) and 53, 50 (DPR-29, 30) were transmitted on the originally submitted pages and not incorporated into the pages revised under Amendments 39, 37 (DPR-19, 25) and 53, 50 (DPR-29-30).

In order to assist in the resolution of this error, we have enclosed revised Pages 88 and 93 for both DPR-19 and DPR-25 and revised Pages 3.6/4.6-2 and 3.6/4.6-9 for both DPR-29 and DPR-30. The revisions incorporate the approved amendments transmitted in Reference (a) into the latest approved version of the specified pages and include your assigned amendment numbers.


