# Meeting Summary

Areas Discussed: Three apparent violations were presented. The first, failure to perform adequate post-maintenance testing (e.g., local leak rate testing), resulted in the "Unit 3 Torus and Drywell Outer Isolation Purge Valve, " 3-1601-24, being unknowingly left partially open (i.e., subsequent local leak rate testing could not pressurize the piping) for approximately 18 months during periods of reactor power operations. Efforts were taken and additional items planned by the licensee to ensure that necessary post-maintenance testing will be performed. The second and third items, concerning the Unit 2 Reactor Building Trackway Outer Door Seal, addressed failures: (1) to perform required design control of the door seal replacement; and (2) to take appropriate compensatory action with door seals manually defeated (e.g., secondary containment degradation). The door seal unauthorized modification has been returned to its original acceptable configuration.

#### 2. Enforcement Conference

An Enforcement Conference was held at the Holiday Inn, in Lombard, Illinois on the afternoon of December 10, 1991. The conference was conducted as a result of the preliminary findings of inspections conducted between August 29, 1991, and November 15, 1991, in which apparent violations of NRC regulations and license conditions were identified. Inspection findings were documented in Inspection Reports No. 50-237/91027(DRP) and No. 50-249/91035(DRS), and were transmitted to the licensee by letters dated November 15, 1991, and November 27, 1991.

The purposes of the enforcement conference were to discuss the apparent violations, their causes, and the licensee's corrective actions; to determine if there were any escalating or mitigating circumstances; and to obtain any other information which would help determine the appropriate enforcement action. Following introductory remarks, the NRC staff opened the conference by stating the purpose of the conference and the NRC concerns, presenting a brief description of the apparent violations, and summarizing the inspection findings. The licensee did not contest any of the apparent violations.

The licensee was requested by the NRC to discuss the following:

- Failure to perform adequate post-maintenance testing (e.g., local leak rate testing) of the Unit 3 Drywell and Torus Outboard Isolation Purge Valve, 3-1601-24;
- Failure to apply appropriate design control in the modification of the Unit 2 Reactor Building Trackway Outer Door Seal; and
- Failure to take necessary compensatory action with the Unit 2 Reactor Building Trackway Outer Door Seal manually defeated.

The licensee presented their assessment of the above apparent violations. The licensee described the events which led to the apparent violations, including root causes and corrective actions taken or planned, and presented their determination of the safety significance. (See Enclosure 2)

At the conclusion of the conference, the licensee was informed that they would be notified of the final enforcement action in subsequent correspondence.
