Dear Mr. Gilliam:

Enclosed is Amendment No. 19 to your NRC Material License No. 24-17998-02 in accordance with your May 15, 2017 request (ML17138A268), with the exception of adding Edward C. Dickerson, M.S., as an Authorized Medical Physicist (AMP). Please review the enclosed license amendment document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9892 so that we may provide appropriate corrections and answers.

As we discussed, to add Mr. Dickerson as an AMP, additional documentation is needed to confirm that his training and experience as related to gamma stereotactic radiosurgery (GSR) applications meets criteria outlined in 10 CFR 35.51. As noted in previous correspondence, this information may be submitted via an NRC Form 313 (AMP). A preceptor attestation confirming the GSR training and experience is required. This decision is without prejudice to resubmission.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
