This refers to your license amendment request dated May 25, 2017. Please find enclosed Amendment No. 6 removing the requested facility. Your facility located at 118 Sandhill Drive, Suite 104, Middletown, Delaware may be released for unrestricted use. We understand from your letter that the two dose calibrator sources and the flood source have been moved to your Newark location. Please advise us immediately if this is incorrect.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
