Dear Mr. Hall:

Enclosed is Amendment No. 8 renewing your NRC Material License No. 13-26779-01 in accordance with your request.

Your license has been renewed for a ten year term and will not expire until June 30, 2027.

We prepared this amendment using our new Web Based Licensing system (WBL).

In particular, Subitem Nos. 6. through 9., A. through E., inclusive, now are listed according to radionuclide, activity, manufacturer, etc.

In addition, we added Michael Antalis as your Alternate Radiation Safety Officer (RSO). In the telephone discussion between you and me on June 5, 2017, I had requested that you submit a signed and dated Delegation of Authority for Mr. Antalis and that you include a stipulation that he would only act as RSO in your physical absence.

We received your response letter dated June 13, 2017, which contained the Delegation of Authority. However, it did not include the requested stipulation. Therefore, I have added Condition No. 11.B., which includes the stipulation that Mr. Antalis may only act as RSO in your physical absence.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC Public Document Room or from the NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.


