This letter provides transmittal of the subject Inservice Inspection (ISI) Plan revision. In order to aid in the review of this revision, two attachments have been included. Attachment 1 provides a description of the ISI Plan changes for Revision 4. Attachment 2 provides instructions on which pages must be replaced or added to Revision 3 of the ISI Plan and includes those revised pages.

Revision 4 of the ISI Plan includes one new Relief Request (PR-19) which has the potential to impact the current forced outage (D2F23). Relief Request PR-19 addresses an alternate pressure testing requirement for the replaced Main Steam Line Drains which are not isolable from the reactor vessel. It is the intent of Dresden Station to utilize this Relief Request, if approved, for the pressure testing requirement for the Main Steam Line Drains which were replaced during the D2F23 forced outage. Therefore, ComEd requests NRC staff review and approval by October 26, 1994.
