This refers to your license amendment requests dated March 13 and May 8, 2017. Please find enclosed Amendment No. 73 releasing Rooms N10-28, 2-73/A, and 6-30 for unrestricted use, removing Tyrone L. Daniels, M.D. as an authorized user and changing the Radiation Safety Officer to 1LT Monique M. Patron.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).


