Dear Sir or Madam:

The Nuclear Energy Institute (NEI) Nuclear Strategic Issues Advisory Committee (NSIAC) approved an Industry Initiative to implement and maintain Severe Accident Management Guidelines (SAMGs) [Reference 1]. James A. FitzPatrick Nuclear Power Plant (JAF) provided a letter committing to their recommended actions [Reference 2].

This letter addresses one commitment to implement revision 3 of the Boiling Water Reactor Owner's Group (BWROG) generic severe accident guidelines by June 30, 2017. The BWROG guidelines are a template for the site Emergency Procedure Guidelines (EPG) and Severe Accident Guidelines (SAG) procedures and implementing revision 3 updates the methodology used in these procedures.

The EPG portion of the revision 3 guidelines were implemented concurrent with JAF complying with NRC Orders EA-12-049, FLEX and EA-12-051, Spent Fuel Instrumentation. The SAG portion of revision 3 guidelines are scheduled to be implemented concurrent with JAF's compliance with Phase 1 of EA-13-109, Reliable Hardened Containment Vent, due June 30, 2018. A change was made to the commitment to align with this date.

The Attachment to this letter summarizes the change made to the regulatory commitment in Reference 2. This letter contains no new regulatory commitments.
