Enclosed is Amendment No. 2 renewing your U.S. Nuclear Regulatory Commission (NRC) Material License No. 21-32644-01 in accordance with your request dated March 23, 2017. Your request is available electronically from the NRC's Agencywide Documents Access and Management System (ADAMS) at Accession No. ML17088A749.

Amendment No. 2 to your NRC License No. 21-32644-01 was generated using a Web-Based Licensing System. In accordance with NRC policy, we have deleted Condition No. 13 regarding the need for decommissioning financial assurance. We have also deleted Condition No. 14 and included the reference to 10 CFR, Part 71, "Packaging and Transportation of Radioactive Material," in the preamble, on page 1 of the license.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. The NRC may issue a notice of violation, imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
