Specifically, the amendments would revise the technical specifications based on Technical Specifications Task Force (TSTF) Travelers TSTF-411, "Surveillance Test Interval Extensions for Components of the Reactor Protection System (WCAP-15376-P)," and TSTF-418, "RPS [Reactor Protection System] and ESFAS Test Times and Completion Times (WCAP-14333)."
