During this meeting the NRC staff provided an overview of the License Renewal review process, application requirements, staff recommendations and application of lessons learned, typical review schedule, and conducted coordination of a follow on pre-license renewal application coordination meeting. During this meeting Entergy agreed to conduct, within a month's time, an overview of the contents of their proposed LRA, a discussion of the application of lessons learned from previous applications, as well as logistical details regarding an LRA submission.
