By letter dated May 18, 2017 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML17156A815), Westinghouse Electric Company (Westinghouse) submitted an approval ("-A") version of topical report (TR) WCAP-17202-P-A/WCAP-17202-NP-A, Revision 0-1, "Supplement 4 to BISON Topical Report RPA 90-90-P-A," to the U.S. Nuclear Regulatory Commission (NRC) staff. Westinghouse has done so in accordance with our request to publish approval proprietary and non-proprietary versions of this TR, as detailed in the transmittal letter of the NRC staff's final safety evaluation (ADAMS Accession No. ML16224A140) for the WCAP-17202-P-A/WCAP-17202-NP-A, Revision 0-1.

The NRC staff has completed its review of the approval version of the TR. The NRC staff verified that Westinghouse has met the requirements and determined that the submitted -A versions are acceptable for referencing in licensing applications for nuclear power plants to the extent specified, and under the limitations delineated in the accepted versions of the TR. WCAP-17202-P-A/WCAP-17202-NP-A, Revision 0-1, is now approved for use in future licensing actions.
